

**Contract Agreement for the
PURCHASE OF MEDAL FOR OUTSTANDING STUDENTS**


THIS AGREEMENT, made this 29th day of February, 2016 between the Municipal Government of Dinalupihan, a local government unit with principal address at Barangay San Ramon, Dinalupihan, Bataan, herein referred to as the "Entity" represented by its Municipal Mayor, HON. MARIA ANGELA S. GARCIA and APOLLO MERCHANDISE AND LIGHTS AND SOUNDS SYSTEM, represented herein by its Owner, MR. JUANITO B. DE LEON, with office address at 154 Hypherion St. Apollo, Orani BataanBataan, herein referred to as the "Supplier".


WHEREAS the Entity invited Contractor for the Purchase of Medal for Outstanding Students and has accepted a Bid by the Contractor in the sum of Seven Hundred Forty Four Thousand Pesos (Php744,000.00), hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


