Bidders should have completed, within two (2) from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. - 6. A complete set of Bidding Documents may be purchased by interested Bidders on *July 16-23, 2019* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *One Thousand Pesos (Php1,000.00)*.
- 7. Bids must be delivered to the address below on or before *July 24, 2019 at 10:00 in the morning*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

- 8. Bid opening shall be on *July 24, 2019 at 10:00 in the morning at BAC Office 2<sup>nd</sup> Floor Municipal Bldg, Dinalupihan, Bataan.* Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
