INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

**"CONCRETING OF BARANGAY ROAD SAMPAGUITA STREET, BARANGAY MALIGAYA,
DINALUPIHAN, BATAAN"**

The LGU Dinalupihan, Bataan, through **MUNICIPAL FUND** for the contract approved by the Municipality of Dinalupihan for 2020 intends to apply the sum of **ONE MILLION ONE HUNDRED FORTY-SIX THOUSAND SEVEN HUNDRED FIFTY-SEVEN PESOS & FIFTY-ONE CENTAVOS (P1,146,757.51)** being the Approved Budget for the Contract (ABC) to payments under the contract **CONCRETING OF BARANGAY ROAD SAMPAGUITA STREET, BARANGAY MALIGAYA, DINALUPIHAN, BATAAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The LGU Dinalupihan, Bataan now invites bids **CONCRETING OF BARANGAY ROAD SAMPAGUITA STREET, BARANGAY MALIGAYA, DINALUPIHAN, BATAAN** in accordance with the attached drawings and technical specifications. The said project shall include the provision of labor, materials, equipment, application and securing of all permits and other incidentals necessary to complete the works for, but not limited to: excavation clearing and grubbing, and general/other requirements as identified in the official documents for the **CONCRETING OF BARANGAY ROAD SAMPAGUITA STREET, BARANGAY MALIGAYA, DINALUPIHAN, BATAAN**. Completion of the Works is required by **Twenty-Six (26) calendar days**. Bidders should have completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from LGU Dinalupihan, Bataan and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday**.

A complete set of Bidding Documents may be acquired by interested Bidders on **May 12, 2020** from BAC office LGU Dinalupihan, Bataan and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P5,000.00)**.



Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
