Consultancy 2021-01**


1. The *Municipality of Dinalupihan*, through the *Municipal Fund of 2021* intends to apply the sum of *Five Million One Hundred Eighty Nine Thousand Two Hundred Ninety Six Pesos (Php5,189,296.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for ***Consulting Services for Master Plan on Drainage Improvement in Municipality of Dinalupihan***. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Municipality of Dinalupihan* now calls for the submission of eligibility documents for consultancy services that will provide Master Plan on Drainage Improvement in Municipality of Dinalupihan to determine the characteristics and problems of flood and urban drainage within and around the Dinalupihan Area with accuracy. Interested consultants must submit their eligibility documents on or before *November 12, 2021, 10:00 in the morning* at *BAC Office, 2nd Floor Municipal Brgy. San Ramon, Dinalupihan, Bataan*. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. The BAC shall draw up the short list of consultants from those who have submitted [*eligibility documents/Expression of Interest*] and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of *three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:


CRITERIA	% WEIGHT
Specific Experience of Consultant Relevant to the Assignment	20%
Adequacy of Proposed Methodology & Work Plan	35%
Qualification of the Proposed Key Experts	40%
Participation of Nationals	5%
TOTAL	100%


4. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
5. The Procuring Entity shall evaluate bids using the *Quality Cost-Based Selection (QCBS)*.
6. The contract shall be completed within *one hundred twenty (120) calendar days*.

7. The *Municipality of Dinalupihan* reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
