




INVITATION TO BID


Procurement of Security Services (3rd Quarter 2022) PB 2022-10

1. The Local Government of Dinalupihan, through the Local Government Unit Operating Budget 2022 intends to apply the sum of Two Million One Hundred Forty Five Thousand Pesos (Php2,145,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Security Services (3rd Quarter 2022). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government of Dinalupihan now invites bids for Procurement of Security Services (3rd Quarter 2022). Deployment of Personnel Security starts on July 1, 2022 to September 30, 2022. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
5. Prospective Bidders may bring Letter of Intent to obtain and acquire Bidding Documents at Bids and Award Committee Office, 2nd Flr. Municipal Hall Dinalupihan, Bataan from 8:00 in the morning until 5:00 in the afternoon. A complete set of Bidding Documents may be acquired by interested Bidders on May 30 to June 6, 2022 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php5,000.00)
6. Pre-bid Conference will be held on *May 31, 2022 at 3:00 in the afternoon* at BAC Office 2nd Floor Municipal Bldg, Dinalupihan, Bataan.
7. Bids must be duly received by the BAC Secretariat to the address below on or before *June 7, 2022 at 3:00 in the afternoon*. Late bids shall not be accepted. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

8. Bid opening shall be on *June 7, 2022 at 3:00 in the afternoon at BAC Office 2nd Floor Municipal Bldg, Dinalupihan, Bataan*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
9. The *LGU of Dinalupihan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
