ORDER

On 29 April 2016, the Peninsula Electric Cooperative, Inc. (PENELCO) and San Miguel Energy Corporation (SMEC) filed a *Joint Application* for approval of their Power Supply Contract (PSC), with prayer for the issuance of provisional authority and confidential treatment of information.

On 03 May 2019, the Supreme Court issued its *Decision* in *Alyansa Para Sa Bagong Pilipinas (ABP), Inc. v. Energy Regulatory Commission (ERC), et al.*¹, requiring all applications for power supply agreements filed before the Commission on or after 30 June 2015 to comply with the Competitive Selection Process (CSP) in accordance
