On 04 April 2016, the Peninsula Electric Cooperative, Inc. (PENELCO) and GNPower Ltd. Co. (GNPOWER) filed their *Application* for approval of their Power Purchase and Sale Agreement (PPSA), as amended, with motions for confidential treatment of information and issuance of provisional authority.

On 03 May 2019, the Supreme Court issued its *Decision* in *Alyansa Para Sa Bagong Pilipinas (ABP), Inc. v. Energy Regulatory Commission (ERC), et al.*¹, requiring all applications for power supply agreements filed before the Commission on or after 30 June 2015 to comply with the Competitive Selection Process (CSP) in accordance with the Department of Energy (DOE) Circular No. 2018-02-0003²
