**ORDER OF CANCELLATION**

**WHEREAS**, the Pagalanggang National High School Teachers and Employees Consumers' Cooperative (PNHSTECO) with official address at Pag-asa Street, Pagalanggang, Dinalupihan, Bataan is a registered cooperative organization pursuant to the provisions of R.A. 9520 under Certificate of Registration No. 9520-03021485, dated 3/22/2012.

**WHEREAS**, this cooperative after due notice and hearing for involuntary dissolution has been found incapable of continuing its cooperative business having been proven to have no assets;

**WHEREAS**, this office have issued the order of dissolution of this cooperative on 6/18/2015.

**WHEREAS**, the MC 2012-21, Chapter II, Section 1 citing Section 17, Rule 9, of the IRR provides for exception in the liquidation process, to wit:

*"Section 17. EXCEPTION.*


*The Authority, at its own discretion, may outrightly cancel the Certificate of Registration of a cooperative which has been proven to have no assets, or in case the cooperative can no longer be located despite the best efforts to locate it. Such facts shall be stated in the Order of Cancellation."*

**NOW, THEREFORE**, by virtue of the powers and duties vested in me, I hereby order the cancellation of the Certificate of Registration of the Pagalanggang National High School Teachers and Employees Consumers' Cooperative (PNHSTECO) under Registration No. 9520-03021485, dated 3/22/2012 pursuant to Section 3(g) of R.A. 6939.

It is likewise ordered that a copy of this Order shall be posted in the community where the cooperative has its principal office and the Authority's bulletin boards.

Further, the authority shall remove the name of the above-stated cooperative in the Registry of Cooperatives, and cause the publication of the notice of cancelled cooperatives.
