O R D E R

Petitioner Marionette Santos Gloria through her counsel Atty. Edmundo S. Cari-an, filed the instant Verified Petition on December 06, 2018 praying *“that after due publication and hearing, a Decision issue of this Honorable Court ordering that the later registered birth certificate of petitioner (ANNEX “A”) be maintained and the Date and Place of Marriage of her parents be corrected to reflect the date September 23, 1988, as the correct date of marriage, and Ermita, Manila as the Place of Marriage, and the name of his father as Reynaldo Reyes Gloria Jr., and to unblock the concerned birth certificate of the petitioner, or in the alternative, the first registered birth certificate of petitioner be maintained and will be corrected to reflect her surname as GLORIA, thus, MARIONETTE SANTOS GLORIA, the name of her father as REYNALDO REYES GLORIA JR., and that the Date and Place of Marriage of her parents also, be corrected to reflect the date September 23, 1988, and Ermita, Manila, as the place of marriage .”*

The petitioner alleges: *“that petitioner is of age, single, Filipino, and residing at #03 Brgy. Bamban, Hermosa, Bataan, where she may be served with the legal processes of this Court; while respondents are being impleaded herein in their official capacity/ies, namely: THE CIVIL REGISTRAR OF DINALUPIHAN, BATAAN, with address at*




Dinalupihan, Bataan, the OFFICE OF THE SOLICITOR GENERAL, Amorsolo St., Makati City; OFFICE OF THE PROVINCIAL PROSECUTOR OF BATAAN, Balanga City, OFFICE OF THE CIVIL REGISTRAR GENERAL, PHILIPPINE STATISTIC AUTHORITY, Quezon City; where they may be served with summons and other legal processes of the Court; that petitioner was born on July 31, 1992 at Dinalupihan, Bataan, with parents Spouses Estrella Dayrit Santos and Reynaldo Reyes Gloria Jr., where it appeared that they were married on September 24, 1988, at Caloocan City, a copy of her birth certificate issued by the National Statistic Office, is hereto attached as ANNEX "A", and the Marriage Contract of her parents is hereto attached as ANNEX "B" with Registry No. 88-23240, where it appeared that they were married on September 23, 1988, at Ermita, Manila; that petitioner has been using ANNEX "A", and the name MARIONETTE SANTOS GLORIA in all her school records from her elementary years and at Lyceum of Subic Bay, Olongapo City, where she graduated, major in accountancy, and also official identification documents; that lately, when she tried to get a certified true copy of her birth certificate from the Philippine Statistic Authority, she was surprised to learn that there was a prior birth certificate registered in the name of MARIONETTE SANTOS GAGNO and her father as MARIO GALIMBA GAGNO, and the date of marriage of her parents as October 6, 1990, at Dinalupihan, Bataan, and the informant is Bernadette Santos, copy of which is hereto attached as ANNEX "C", with Registry No. 92-1552; that, further, she was informed that ANNEX "A" was already blocked and can not be accessed without authorization from the Court; that there is a need to reflect all the correct data and circumstances surrounding the birth of petitioner."

WHEREFORE, finding the petition to be sufficient in form and substance, the same is hereby set for hearing on **April 16, 2019 at 9:00 o'clock in the morning** and all interested persons are hereby required to appear and show cause, if any they have, why the petition should not be granted.

Let copies of this Order be furnished the Office of the Local Civil Registrar General, Philippine Statistics Authority, the Local Civil Registrar of Dinalupihan, Bataan.

The Sheriff of this court is hereby directed to post copies of this Order in the Bulletin Board of this court and the Office of the Clerk of Court (OCC)-RTC Dinalupihan, Bataan, at the Provincial Capitol of Bataan, Balanga City, Bataan, in the Municipal Hall of Dinalupihan, Bataan for three (3) consecutive weeks prior to the date of hearing.



Likewise, let copies of this Order be published, at the expense of the petitioner, in a newspaper of general circulation in the Philippines for three (3) consecutive weeks, the last publication of which should be at least one (1) week before the date of hearing.
